****PE Riding Club Rules and Code of Conduct****

1. **Behaviour and Etiquette**: Members should conduct themselves in a manner that promotes the ethos of the club, which includes respect for others, both human and animal. Unruly or disruptive behaviour will not be tolerated and may lead to suspension or expulsion from the club after disciplinary action.
2. **Safety First**: Always wear a helmet when riding. Protective gear, such as gloves and appropriate footwear, is recommended. Members are encouraged to practice safe riding at all times and to immediately report any hazards or accidents to staff.
3. **Alcohol and Substances**: Bringing alcohol and illegal substances onto the premises is strictly prohibited. Any member found violating this rule will be subject to an immediate fine of R500 and disciplinary action.
4. **Dogs on Leashes**: All dogs brought onto the premises must always remain on a leash. This is to ensure the safety of both animals and riders. Owners must clean up after their dogs. Owners whose dogs are found off leash will be subject to an immediate fine of R300.
5. **Respect for Arena Rules**: All riders must adhere to the arena rules, including but not limited to:
 - No riding inside of the arenas without prior booking.
 - No horses in the top parking area during shows.
 - No riding inside of the warm-up arenas if you are not participating at a show.
 - No riding on the facilities without prior consent.
6. **Respect for Horses**: All horses should be treated with kindness, care, and respect. Members should not engage in any behaviour that causes distress or harm to the animals.
7. **Cleanliness and Maintenance**: Members are responsible for disposing of their rubbish properly and ensuring it is not left on tables near the clubhouse or around the stables and arenas. Please use the designated bins provided to keep the premises clean and tidy.
8. **Guests and Visitors**: Any non-member wishing to visit or ride on the premises must be accompanied by a club member. All guests must follow the club's rules and guidelines.
9. **Parking and Vehicle Access**: Vehicles must be parked in designated areas only. Do not block pathways or areas where horses and other vehicles may need to pass.
10. **Children and Junior Riders**: Children must be always supervised by an adult. Parents are responsible for ensuring their children understand and follow all safety protocols.
11. **Club Events and Competitions**: Members are encouraged to participate in club events, but must respect all event-related rules, including arrival times, registration procedures, and conduct during competitions.
12. **Conflict Resolution**: If a member has a concern or complaint, it should be addressed in a respectful manner. The club leadership is available to mediate and resolve any issues fairly.
